Facilitation and payment for the Official Receipt / Certificate of Registration (OR/CR) with the Land Transportation Office (LTO)</li><li>3. Facilitation and payment for the Third Party Liability (TPL) and first three (3) years of Comprehensive Insurance with the Government Service Insurance System (GSIS)</li><li>4. Facilitation of the vehicles' Red Plate Numbers</li><li>5. The fuel tank must be full upon arrival at the point of destination.</li><li>6. Provision of dash camera (front and rear) with free 62 GB memory card, hydraulic jack, early warning device, steering wheel , leather/ leatherette cover, seat cover</li><li>7.
