**RESOLUTION NO.1414** Series of 2021

## DESIGNATING DAVAO, LEGAZPI, TACLOBAN, PAGADIAN, AND ZAMBOANGA AS ADDITIONAL TESTING CENTERS FOR THE OCTOBER 2021 **GEODETIC ENGINEERS LICENSURE EXAMINATION**

WHEREAS, Section 7 (d) of Republic Act No. 8981, otherwise known as the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, pursuant to PRC Resolution No. 1283 (s. 2020), the schedule for Geodetic Engineers Licensure Examination (GELE) is on October 6 & 7, 2021, to be held in the National Capital Region (NCR), Baguio, Cebu, and Tuguegarao;

WHEREAS, the Commission received endorsement letters from the PRC Regional Offices of Davao, Legazpi, Tacloban, Pagadian, and Zamboanga requesting for their inclusion as testing centers for the October 2021 GELE;

WHEREAS, in view of the health measures imposed by the government to mitigate, if not contain, the spread of COVID-19 through, but not limited to, social distancing and travel restrictions, the Professional Regulatory Board of Geodetic Engineering endorsed the approval of the above request for the welfare of the prospective examinees from the said cities by allowing them to take the October 2021 GELE without unnecessary distant travel and additional expenses;

WHEREAS, the PRC Regional Offices of Davao, Legazpi, Pagadian, and Zamboanga gave their respective concurrence with regard to their inclusion as testing centers for the October 2021 GELE and assured that they have the budgetary requirements, supplies, and manning complement for the conduct of the same;

WHEREFORE, the Commission RESOLVES, as it hereby RESOLVED, to designate DAVAO, LEGAZPI, TACLOBAN, PAGADIAN, and ZAMBOANGA as additional testing centers for the October 2021 Geodetic Engineers Licensure Examination.

**RESOLVED FURTHER**, that necessary coordination be undertaken by the appropriate offices/divisions of the Commission to ensure the smooth and orderly conduct of said licensure examination in these testing centers.

**RESOLVED FINALLY**, that a copy of this Resolution be posted at the PRC Official website for the information and guidance of all concerned.
