RESOLUTION NO. 1416

CONDUCTING THE REGISTERED ELECTRICAL ENGINEERS AND **REGISTERED MASTER ELECTRICIANS LICENSURE EXAMINATIONS IN CEBU ON** SEPTEMBER 5, 6 & 7, 2021, RESPECTIVELY

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1283 (s. 2020) scheduling the Licensure Examinations for Registered Electrical Engineers (REE) and Registered Master Electricians (RME) on April 20-22, 2021 and September 4-6, 2021, respectively;

WHEREAS, the Commission issued Resolution No. 1394 (s. 2021) postponing the April 2021 Licensure Examinations for REE and RME and rescheduling the same to September 5 & 6, 2021 and September 7, 2021, respectively;

WHEREAS, with the denial of the request of PRC-Cebu to conduct the REE and RME Licensure Examinations in Cebu City under the Modified Enhanced Community Quarantine until September 7, 2021, the Commission issued Resolution No. 1412 (s. 2021) cancelling the REE and RME Licensure Examinations on September 5, 6 & 7, 2021 in Cebu;

WHEREAS, on September 1, 2021, after rigorous consultation with the Emergency Operations Center (EOC) of the City Government of Cebu and through the clamor of examinees who appealed for the reconsideration of the cancelled licensure examinations, the conduct of the September 2021 licensure examinations scheduled in Cebu, including the REE and RME Licensure Examinations, was reconsidered and approved by the Regional Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID);

WHEREAS, per recommendation of the EOC, the following measures shall be strictly implemented, to wit:

- 1. COVID Testing shall be required prior to the scheduled examination:
 - NPS/OPS RT-PCR from DOH-accredited molecular laboratories taken seventya. two (72) hours prior to scheduled exam; OR
 - Antigen testing from DOH-accredited laboratories (Cebu Doctor's Hospital. b. University of Cebu Medical Center, Chong Hua Hospital - Fuente, ARC Hospital, Prime Care) 24 hours prior to the scheduled exam;
- 2. Examinees shall be allowed to take their meals only in their respective examination cubicles: and
- 3. All examinees must be requested to go home immediately after the examination day.

WHEREAS, the Professional Regulatory Board of Electrical Engineering and Licensure Office deemed it necessary to endorse to the Commission the holding of the September 5, 6 & 7, 2021 REE and RME Licensure Examinations in Cebu.

WHEREFORE, in view of the foregoing, the Commission RESOLVES, as it hereby RESOLVED, to conduct the September 5, 6 & 7, 2021 REE and RME Licensure Examinations in Cebu.
