GENERAL INSTRUCTIONS:

- 1. Check or verify your school/building assignments at the PRC official website (www.prc.gov.ph) or through the Notices/Announcements to be posted at the PRC premises two (2) or three (3) working days before the examination. Bring your **NOTICE OF ADMISSION** when you verify your school/building assignment. Visit your school/building assignment prior to the day of the examination.
- 2. Report to your school/building assignment before 5:30 a.m. on the first (1st) day of the examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
- 3. Examinees are required to wear the following attire every examination day:

Male examinees - Tucked-in white polo shirt with collar (without any seal, logo or mark)

Decent pants or slacks

Female examinees - Tucked-in white blouse or shirt with collar (without any seal, logo or mark)

Decent pants, slacks or skirts

Pony-tailed long hair

- 4. Bring the following on the days of the examination:
 - a. Notice of Admission
 - b. Official Receipt
 - c. Two (2) or more pencils (No. 2)
 - d. One (1) piece long brown envelope
 - e. One (1) piece long transparent/non-colored plastic envelope (for keeping your valuables and other allowed items)
 - f. NON-PROGRAMMABLE CALCULATORS. (Please refer to Board Resolution No. 05, s. 2024 or "Recommending an Updated List of Non-Programmable Calculators Allowed to be Used in the Civil Engineering Licensure Examination")

NOTE: ONLY ONE (1) CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. CALCULATORS SHALL BE INSPECTED AND SHALL BE RESET BEFORE THE START OF THE EXAMINATION.

- 5. The following are **PROHIBITED** inside the examination premises/rooms:
 - Books, notes, review materials, and other printed materials containing coded data/information/formula
 - b. PROGRAMMABLE CALCULATORS
 - c. APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSE
 - d. Bags of any kind (ladies bag, shoulder bags, attache case, backpacks, etc.)
 - e. Other examination aids not stated in this program.

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57 (s. 2020) shall be strictly observed.

- 6. Examinees and examination personnel are encouraged to observe the minimum health standards per DOH Circular No. 0324 (s. 2023)¹ throughout the conduct of the examination.
- 7. Read carefully and follow the instructions on your Notice of Admission and Examinees Guide.
