**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID
(Mode of Procurement : Public Bidding)**

- I. The PROFESSIONAL REGULATION COMMISSION REGIONAL OFFICE IX (PRC-IX), through its Regional Bids and Awards Committee (RBAC), with authorized appropriation for fiscal year (FY) 2021 (R.A. No. 10155, General Appropriation Act), now invites interested private security agencies/service providers/bidders duly registered with the Philippine Government Electronic Procurement System (PhilGEPs) to apply for eligibility and to bid through public bidding for the hereunder project:

Other Requirements	The complete Project's Terms of Reference (TOR), scope of services, specification requirements and bidding requirements are included in the manual of bidding documents with non-refundable fee of Php5,000.00.

- II. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- III. Prospective bidders should have at least five (5) years experience in undertaking frontline security services for the period January 2016 to present with a permanent office address in Region IX Pagadian/Zamboanga Peninsula. The Bidders should have had a single contract similar to the Project with an amount of at least 50% of the ABC. The description of an eligible Bidder is contained in Section II of the Bidding Documents, Instructions to Bidders (ITB).
- IV. Prospective Bidder must comply with Section 9 of DOLE Department Order No. 18-A, S.2011.
- V. Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the Implementing Rule and Regulations (IRR) of RA 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is open to all interested Bidders subject to the conditions for eligibility provided in the IRR of RA 9184.
- VI. Bidding is restricted to Filipino citizens, sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA no. 5183 and subject to Commonwealth Act No. 138.
