PROVISION OF MULTI-YEAR SECURITY SERVICES FOR PRC CAGAYAN DE ORO
REGIONAL OFFICE X AND ITS OFFSITE SERVICE CENTERS

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION (PRC) CAGAYAN DE ORO REGIONAL OFFICE X, an agency of the National Government, with office address at Skypark, Limketkai Center, Cagayan de Oro City, represented by its Regional Director, **MS. JULIE L. SABALZA**.

-and-

VV SECURITY AGENCY, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at Door 8, Sheridan Building, Calamansi Drive, Carmen, Cagayan de Oro City, herein represented by its General Manager, **MS. DENVI T. CABRERA**.

WITNESSETH THAT:

WHEREAS, PRC invited Bids for the Provision of Multi-Year Security Services for PRC Cagayan de Oro Regional Office X and Its Offsite Service Centers through a Multi-Year Contracting Authority No. MYCA-BMB-B-21-0000015 dated 27 May 2021 as described and enumerated in Section VI or the Schedule of Requirements, and has accepted the Bid of **VV Security Agency, Inc.** for the goods and services in the sum of **ONE MILLION NINE HUNDRED NINETY FOUR THOUSAND SIX HUNDRED EIGHTY ONE PESOS AND 04/100 (P1,994,681.04)** for the first year of the multi-year contract, inclusive of VAT. (Hereinafter called "the Contract Price").

WHEREAS, upon evaluation and recommendation of the Regional Bids and Awards Committee, and approved by the Regional Director as the Head of Procuring Entity, **VV Security Agency, Inc.** was declared to be the Single Calculated and Responsive Bidder (SCRB) for the project: Provision of Multi-Year Security Services for PRC Cagayan de Oro Regional Office X and Its Offsite Service Centers.

NOW THEREFORE, for and in consideration of the above mentioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **VV Security Agency, Inc.** have agreed as follows:


1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, herein attached as Annexes "A to H" shall be deemed to form and be read and construed as part of this Contract, viz:
 - A. The Official Bid Form and the Price Schedule submitted by **VV Security Agency, Inc.**;
 - B. The Schedule of Requirements acknowledged by **VV Security Agency, Inc.**;

- C. The Technical Specifications acknowledged by **VV Security Agency, Inc.**;
 - D. Bid Bulletin No. 1;
 - E. The General Conditions of Contract;
 - F. The Special Conditions of Contract;
 - G. PRC's Notification of Award; and
 - H. The Affidavit of Undertaking executed by **VV Security Agency, Inc.**
3. That **VV Security Agency, Inc.** shall regularly and closely check the Security Guards in the performance of their duties and responsibilities and to ensure that they are properly discharging their duties and responsibilities and not committing any act(s) prejudicial to the interest of PRC.
4. In consideration of the payments to be made by **PRC** to **VV Security Agency, Inc.**, hereby agrees to provide the goods and services in conformity in all respects and purpose with the provisions of this Contract.
5. In case a higher daily wage or monthly salary shall be decreed by the President or proper authorities during the effectivity of the contract, any corresponding adjustments made therein shall be subject to the availability of funds of PRC.
6. This contract shall be effective and be in force from January 2022 to October 2024, subject to certain terms and conditions that may be mutually agreed by the parties, in accordance with the provisions of Republic Act No. 9184, otherwise known as "Philippine Government Procurement Reform Act", The 2016 Revised Implementing Rules and Regulations and its related issuances.


