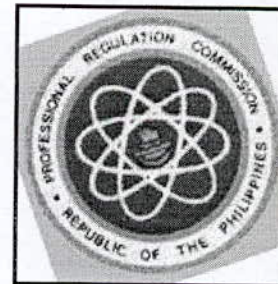

**RECOMMENDING TO THE REGIONAL DIRECTOR OF THE
PROFESSIONAL REGULATION COMMISSION CAGAYAN DE ORO
REGIONAL OFFICE X FOR HER APPROVAL THE AWARDING OF
CONTRACT FOR THE PROVISION OF MULTI-YEAR SECURITY SERVICES
FOR PRC CAGAYAN DE ORO REGIONAL OFFICE X AND ITS OFFSITE
SERVICE CENTERS WITH TOTAL BID AMOUNT OF ONE MILLION NINE
HUNDRED NINETY FOUR THOUSAND SIX HUNDRED EIGHTY ONE
PESOS & 04/100 (P 1,994,681.04)**

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding, the Regional Bids and Awards Committee (RBAC) posted on November 3, 2021 an Invitation to Bid at the Philippine Government Electronic Procurement System (PhilGEPS), PRC website and in the conspicuous place within the premise of the PRC Cagayan de Oro Regional Office X, for the Provision of Multi-Year Security Services for PRC Cagayan de Oro Regional Office X and its Offsite Service Centers through the Multi-Year Contractual Authority (MYCA) No. MYCA-BMB-B-21-0000015 dated 27 May 2021 with an Approved Budget for the Contract (ABC) in the amount of **Two Million Twelve Thousand Pesos only (P 2,012,000.00)** for the first year of the multi-year contract (34 months contract from January 2022 to October 2024).

WHEREAS, on November 10, 2021, during the pre-bid conference held at De Luxe Hotel, V. Roa St., Barangay 38, Cagayan de Oro City, there were five (5) prospective bidders who attended the face-to-face pre-bid conference, namely: 1) Southgate Agency, 2) Philvets Agency, 3) BESIDA Security Agency, 4) ACD Investigation Security Agency (ACDISA), Inc., 5) VV Security Agency, Inc.


WHEREAS, on November 15, 2021, Bid Bulletin No. 1 was issued and posted at the PhilGEPS, PRC website and in the conspicuous place within the premise of the PRC Cagayan de Oro Regional Office X to officially make clarifications on issues and queries raised by prospective bidders during the pre-bid conference, and thus, to supersede the previous issuance relative to the subject procurement.

WHEREAS, on November 22, 2021, on the deadline and submission of bids, three (3) bidders submitted their bids, namely: 1) VV Security Agency, Inc., 2) BESIDA Security Agency, 3) ACD Investigation Security Agency (ACDISA), Inc.





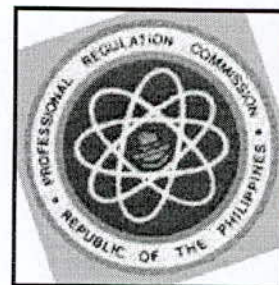

WHEREAS, VV Security Agency, Inc., passed the eligibility requirements and was declared to be the Single Calculated Bidder (SCB) and will be subjected to a post qualification with the bid amount of One Million Nine Hundred Ninety Four Thousand Six Hundred Eighty One and 04/100 (₱ 1,994,681.04).

WHEREAS, on November 26, 2021 at 9:00 o'clock in the morning, the RBAC conducted the post-qualification at the Office of VV Security Agency, Inc. The original documents were validated. VV Security Agency, Inc., passed the post-qualification and was declared to be the Single Calculated and Responsive Bidder (SCRB).

WHEREFORE, the Regional Bids and Awards Committee RESOLVES, as it hereby RESOLVED, to recommend to the Regional Director of the Professional Regulation Commission Cagayan de Oro Regional Office X, for her approval, the award of contract for the Provision of Multi-Year Security Services for PRC Cagayan de Oro Regional Office X and Its Offsite Service Centers to VV Security Agency, Inc., with a bid amount of **ONE MILLION NINE HUNDRED NINETY FOUR THOUSAND SIX HUNDRED EIGHTY ONE AND 04/100 (₱ 1,994,681.04)**.
