INVITATION TO BID FOR PROCUREMENT OF SEKONIC OPTICAL MARK READER INK HP-C6602A **FOR CY 2023**

- 1. The PROFESSIONAL REGULATION COMMISSION (PRC), through the Government of the Philippines (GOP), General Appropriations Act (GAA) of 2023 (Republic Act No. 11936), intends to apply the total sum of Four Hundred Sixty Thousand Pesos (Php460,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Sekonic** Optical Mark Reader Ink HP-C6602A for CY 2023 / ITB No. 2023-16. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PRC now invites bids for the Procurement of Sekonic Optical Mark Reader Ink HP-C6602A for CY 2023. The said project shall be completed within the duration of indicated in the Schedule of Requirements from the date of receipt of Notice to Proceed. Bidders should have completed, within the period from January 2019 up to the date of submission and opening of bids, a contract equivalent to at least fifty percent (50%) of the ABC that is similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a 3. non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Prospective bidders may obtain further information from PRC and inspect the Bidding Documents at the address given below during *office hours*.
- A complete set of Bidding Documents may be acquired by interested Bidders from 5. the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (Php500.00).

The applicable fees paid previously for the same project may be used by the same bidder if the declaration of failure of bidding is pursuant to Section 41. Reservation Clause of RA 9184.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The **PRC** will hold a Pre-Bid Conference at **9:30 AM of April 26, 2023** through video conferencing which shall be open to prospective bidders. For proper coordination, all interested bidders are hereby requested to submit their Letter of Intent to participate, including therein contract details, and send to bac@prc.gov.ph on or before April 24, 2023.
- 7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **9:00 AM of May 8, 2023**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in the form of a Bid Securing Declaration.
- 9. Bid opening shall be at **9:30 AM on May 8, 2023** at the **BAC Conference Room, 4**th **Floor**, **PRC Annex Building**, **P. Paredes St., Sampaloc, Manila**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity via video conferencing.
- 10. The **PRC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
