## **TERMS OF REFERENCE**

# LEASE OF VENUE (INCLUDING FOOD) FOR THE CONDUCT OF THE PROFESSIONAL REGULATION COMMISSION'S (PRC's) 50<sup>TH</sup> FOUNDING ANNIVERSARY NIGHT

#### Rationale

The PRC's 50<sup>th</sup> Founding Anniversary Night is scheduled on **22 June 2023** and will be conducted outside the PRC Central Office premises. To house the one-day activity, an external service provider will be contracted with the following terms and conditions:

### I. APPROVED BUDGET FOR THE CONTRACT

The supplier shall bid for all items described in this TOR, which shall not exceed the Approved Budget for Contract (ABC) of **Two Million Twenty Thousand Pesos (PhP2,020,000.00)**, inclusive of all applicable bank and government charges.

# II. SCOPE OF SERVICE

The contractor should be able to provide the activity venue, food, and other basic amenities with the following specifications:

# **GENERAL REQUIREMENTS**

1. Event Date: 22 June 2023

Time Frame: 5:00 P.M. - 12:00 M.N.

- 3. Location should be in close proximity with or nearby the PRC Central Offices in Metro Manila.



The payment for the services rendered shall be made within 15 - 30 days upon issuance of the Statement of Account (SOA) and shall be a bank-to-bank basis.




