GENERAL INSTRUCTIONS:

1. The **NOTICE OF ADMISSION** will be issued at the Migrant Workers Office/Embassy or testing center.
2. Please bring original documents with you for final evaluation and four (4) pieces passport size pictures with nametag.
3. Bring the following on examination days:
  - a. Notice of Admission
  - b. Two (2) or more pencils (No. 2)
  - c. Ball pens with **BLACK ink only**
  - d. One (1) piece long envelope
  - e. One (1) piece long transparent/non-colored plastic envelope (for keeping your valuables and other allowed items)
  - f. **NON-PROGRAMMABLE CALCULATOR. (PLEASE REFER TO COMMISSION RESOLUTION NO. 1809 (S. 2024) OR THE "UPDATED LIST OF NON-PROGRAMMABLE CALCULATORS ALLOWED TO BE USED IN THE LICENSURE EXAMINATIONS")**



**NOTE: ONLY ONE BASIC CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.**

4. The following are **PROHIBITED** inside the examination premises/rooms.
- Books, notes, review materials, and other printed materials containing coded data/information/formula;
  - Programmable calculator or calculators that can automatically carry out a sequence of operations under control of a stored program, much like a computer and/or with audio-visual features, and/or capable of external communication or internet connectivity, specifically CASIO FX991ES and CASIO FX991ES plus;**
  - CELLULAR PHONES, EARPLUGS, TRANSMITTERS, PORTABLE COMPUTERS, SMART WATCHES, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES;**
  - Bags of any kind (ladies bag, shoulder bags, attache' case, backpacks, etc.);
  - Other examination aids not stated on this program.

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.




