Pursuant to PRC Memorandum Order No. 68 (s.2020), examinees for the licensure examinations are required to submit either (1) a negative RT- PCR Test Results, if falling under the groups stated in DOH Memorandum 2020-258A, or (2) a Certification issued by any of the authorized officer under PRC Memorandum Order No. 68, attesting that the examinee had undergone 14-day quarantine prior to the examination.

These requirements are mandatory and failure to present either of the two, the examinee shall not be allowed to take the licensure examinations.
