- vi. For Statement of Ongoing Contract(s) -amount of contract and value of outstanding contract;
- vii. For Statement of SLCC – amount of completed contract, adjusted by the Bidder to current prices using PSA's consumer price index, if necessary for the purpose of meeting the SLCC requirement;
- viii. Date of delivery; and
- ix. End User's acceptance or Official Receipt(s) or Sales Invoice issued for the contract, if completed, which shall be attached to the statements.

4. Original Notarized Bid Securing Declaration.

5. Conformity with the technical specifications, as enumerated and specified in Sections VI and VII of the Bidding Documents.

*Section VI, Schedule of Requirements, and Section VII, Technical specifications, must form part of the submission of documents.

**Technical Specification shall be supported by submitting samples or evidence of such compliance, as applicable.*

6. Acknowledgment and compliance with Section IV, General Conditions of Contract, and Section V, Special Conditions of Contract, of the Bidding Documents.

*Section IV, General Conditions of Contract, and Section V, Special Conditions of Contract, must form part of the submission of documents.
