The statement shall include all information required in the PBDs prescribed by the GPPB; and
	The statement identifying the single largest completed contract similar to the contract to be bid for the period covering January 2016 up to the date of the submission and opening of bids, except under conditions provided for in Section 23.4.1.3 of the IRR.
