

## CONTRACT FOR THE SECURITY SERVICES 2016

### KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

**PROFESSIONAL REGULATION COMMISSION**, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, cor. Nicanor Reyes Sts. (former Morayta St.), Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

-and-

**AXZEEN SECURITY AGENCY**, a sole proprietorship duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as **ASA** with principal address at L2 B14 PH1 Diho Subdivision, Davao City herein represented by its Proprietor, **MR. ALEX M. AGBAYANI**.

### WITNESSETH THAT:

**WHEREAS**, PRC invited Bids for the Security Services for the year 2016 for PRC Cagayan de Oro Regional Office, and has accepted the Bid of **Axzeen Security Agency** for the supply of goods and services in the sum of **NINE HUNDRED SEVENTY THOUSAND ONE HUNDRED FORTY AND SEVENTY-TWO CENTAVOS ONLY (₱970,140.72)**. (Hereinafter called "the Contract Price");

**WHEREAS**, upon evaluation and recommendation of the Regional Bids and Awards Committee of PRC Cagayan de Oro Regional Office, and approved by the Commission, **ASA** was declared to be the lowest calculated and responsive bidder for the project Security Services 2016;

**NOW THEREFORE**, for and in consideration of the above mentioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **ASA** have agreed as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- E. The Special Conditions of Contract;

- G. The Affidavit of Undertaking executed by **ASA**.

3. In consideration of the payments to be made by the **PRC**, **ASA** hereby agrees to provide the services in conformity in all respects and purposes with the provisions of this Contract.


