**DENTAL HYGIENIST LICENSURE EXAMINATION  
RESULTS RELEASED IN THREE (3) WORKING DAYS**

The Professional Regulation Commission (PRC) announces that **29** out of **50** passed the Dental Hygienist Licensure Examination given by the **Board of Dentistry** in **Manila** this **June 2014**.

The members of the Board of Dentistry who gave the licensure examination are **Dr. Rannier F. Reyes**, Chairman; **Dr. Gloria M. Bumanlag**, **Dr. Steve Mark G. Gan**, **Dr. Melinda L. Garcia** and **Dr. Dominador H. Santos, Jr.**, Members.

The results were released in three (3) working days after the last day of examination.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will be on June 16, 2014. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 1 piece passport size picture (colored with white background and complete name tag), 2 sets of metered documentary stamps and 1 short brown envelope with name and profession and to pay the Initial Registration Fee of ₱450 and Annual Registration Fee of ₱420 for 2014-2017. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oath-taking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER**.
