The Professional Regulation Commission (PRC) announces that **71** out of **138** passed the Environmental Planner Licensure Examination given by the **Board of Environmental Planning** in **Manila** and **Lucena** this **June 2013**.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will be on June 25, 2013. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 1 piece passport size picture (colored with white background and complete nametag), 2 sets of metered documentary stamps and 1 short brown envelope with name and profession and to pay the Initial Registration Fee of P600 and Annual Registration Fee of P450 for 2013-2016. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oath-taking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER.**
