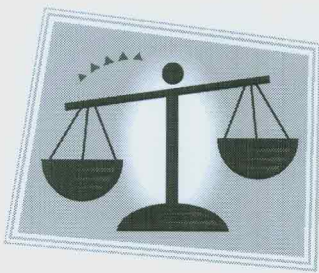

1.	SERVICE PROVIDER REQUIREMENTS:	During Contract Implementation
1.1.	BIDDER must certify that the cable facility being used in the connectivity between the bidder's circuits is exclusively owned and operated by the bidder; all last mile facility must be wired cable.	
1.2.	BIDDER must provide a certification that they are connected or subscribed to Tier 1 or Tier 2 networks or ISPs	
1.3.	BIDDER must provide a certification that it uses own domestic nationwide network and operates its own landing stations, at least 3 cable landing	
1.4.	BIDDER directly connects to Asia Pacific and US Peering partners	
1.5.	BIDDER must provide a certification that its network platform is compliant to the latest MEF carrier Ethernet (2.0)	
1.6.	BIDDER must have at least 3 Cisco Certified Internetworking Expert, 8MEF Carrier Ethernet Certified Professionals 2.0 and Certified Project Manager Professionals (PMP) Technical support personnel	
1.7.	BIDDER must support or IPV6 ready and compliant	
1.8.	BIDDER must Provide a certification that it uses IPVPN Network that supported by a nationwide Domestic Fiber Optic Backbone Network to ensure fast and reliable service across the nation, the bidder must own the facility
