2. Report to the school/building assignment before 6:30 a.m. on the first (1<sup>st</sup>) day of the examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.

3. Examinees are required to wear the following attire every examination day:
- Male Examinees - White polo shirt with collar (without any seal, logo mark)

- Female Examinees - White Blouse or shirt with collar (without any seal, logo or mark)  
Decent pants, slacks or skirt
