## RESOLUTION NO.2013- 14 Series of 2013

## RESCHEDULING THE JULY 2013 BOARD LICENSURE EXAMINATIONS FOR NURSES FROM JULY 6 & 7 TO JUNE 2 & 3, 2013 AND DECEMBER 15 & 16 TO DECEMBER 7 & 8, 2013 WITH NEW DEADLINES FOR FILING OF FIRST –TIMERS' APPLICATIONS ON APRIL 19, 2013 & OCTOBER 25, 2013. AND REPEATER'S APPLICATIONS ON MARCH 29, 2013 & OCTOBER 11, 2013.

WHEREAS, pursuant to Section 7 (d) of R.A. No 8981 ("the PRC Modernization Act of 2000"), the Commission issued Resolution No. 2012-689 dated November 12,2012, which provides for the dates and venues of all the licensure examinations for the Year 2013 as well as the deadline in filing of application;

WHEREAS, the Commission issued Resolution No. 2012-701 Series of 2012, on the Adoption of a Master Schedule of Target Dates of Activities for Year 2013 Licensure Examinations ;

WHEREAS, securing appropriate examination venues has remained a difficulty of PRC Regional Offices; hence, there is a need to solve this problem with better and lasting solutions;

WHEREAS, although the Commission can avail itself of public and private schools as examination venues, these have become less available for use on dates earlier specified due to classes in the same venues; and

WHEREAS, to align the schedule of the NLE to periods where classrooms are more readily available, the rescheduling of the NLE in 2013 examination has been deemed necessary;

**NOW, THEREFORE,** the Board RESOLVES, as it is hereby RESOLVED, to reschedule 2013 BOARD LICENSURE EXAMINATIONS FOR NURSES with their respective schedules for the filing of applications, as follows:
