**PHARMACIST LICENSURE EXAMINATION
RESULTS RELEASED IN ONE (1) DAY**

The Professional Regulation Commission (PRC) announces that **576** out of **1,109** passed the Pharmacist Licensure Examination given by the **Board of Pharmacy** in the cities of **Manila, Baguio** and **Cebu** this January 2012.

The members of the Board of Pharmacy who gave the licensure examination are **Ms. Jennifer M. Flores**, Chairman and **Ms. Marilyn M. Young-Tiu**, Member.

The results were released in one (1) day after the last day of examination.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will start on Tuesday, January 24, 2012 but not later than February 17, 2012. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 2 pieces passport size picture (colored with white background and complete name tag), 1 piece 1+x 1+picture (colored with white background and complete name tag), 2 sets of metered documentary stamps and 1 short plastic envelope with name and profession and to pay the Initial Registration Fee of ₱600 and Annual Registration Fee of ₱450 for 2012-2015. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oathtaking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER.**
