 - e. Ball pens with **BLACK ink only**
 - f. One piece long brown envelope
 - g. One piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
- 5. The following are **PROHIBITED** inside the examination premises/rooms.
 - a. Books, notes, review materials, and other printed materials containing coded data/information/formula.
 - b. PROGRAMMABLE CALCULATORS.
 - c. SMART WATCH, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH and other electronic gadgets/devices which may be used for communication purposes.
 - d. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc.)
 - e. Other examination aids not stated on this program.
