

## REGIONAL BIDS AND AWARDS COMMITTEE PRC TACLOBAN CITY

RESOLUTION No. 2016-37

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION (PRC) THE AWARD OF THE CONTRACT FOR SECURITY SERVICES OF PRC TACLOBAN CITY REGIONAL OFFICE FOR THE YEAR 2016 TO TCO SECURITY AGENCY WITH THE BID AMOUNT OF FIVE HUNDRED SEVENTY-SIX THOUSAND SIX HUNDRED NINETY-SIX PESOS AND FORTY-EIGHT CENTAVOS (Php576,696.48) ONLY

WHEREAS, on March 15, 2016, the Regional Bids and Awards Committee (RBAC) posted the Invitation to Apply for Eligibility and to Bid for the Procurement of Security Services through Public Bidding in the websites of the Professional Regulation Commission (PRC), the Philippine Government Electronic Procurement System (PhilGEPS), and in conspicuous places at the premises of PRC Tacloban City Regional Office with an Approved Budget for the Contract (ABC) in the amount of SIX HUNDRED SIXTY-NINE THOUSAND FOUR HUNDRED PESOS (Php669,400.00);

WHEREAS, in response to the posting with the PhilGEPS, three (3) prospective bidders signified their intention to participate in public bidding, to wit: Vision Security Services, Inc.; TCO Security Agency; and GDS Security & Detective Agency, Inc. However, only one (1) bidder submitted to the RBAC its bid proposal;

WHEREAS, during the opening of bids on April 4, 2016, the RBAC found in order the lone official bid of TCO Security Agency with the bid price of FIVE HUNDRED SEVENTY-SIX THOUSAND SIX HUNDRED NINETY-SIX PESOS AND FORTY-EIGHT CENTAVOS (Php576,696.48), VAT inclusive;

**WHEREAS**, TCO Security Agency passed the preliminary examination of bid documents conducted by the RBAC by using a non-discretionary "pass/fail" criterion;

**WHEREAS**, TCO Security Agency was subjected to post-qualification and ocular inspection on April 6, 2016 to determine the authenticity and genuineness of the eligibility, technical, and financial documents submitted for compliance;

**WHEREAS**, TCO Security Agency, having passed the post-qualification process, was declared to be the Single Calculated and Responsive Bidder (SCRB);

WHEREFORE, the Regional BAC RESOLVES, as it is hereby RESOLVED, to RECOMMEND to the Chairman of the Professional Regulation Commission to award to TCO SECURITY AGENCY, managed by Mr. Benedicto T. Ochea, the contract for the Provision of Security Services for PRC Tacloban City Regional Office for the Year 2016 with the bid amount of FIVE HUNDRED SEVENTY-SIX THOUSAND SIX HUNDRED NINETY-SIX PESOS AND FORTY-EIGHT CENTAVOS (Php576,696.48).


