Resolution No. 2017- 44

**RECOMMENDING TO THE PROFESSIONAL REGULATION COMMISSION (PRC) CHAIRMAN THE AWARD OF CONTRACT FOR THE PROVISION OF SECURITY SERVICES (2017) WITH THE TOTAL BID AMOUNT OF SIX HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED EIGHTY THREE PESOS AND FIFTY TWO CENTAVOS (P681,983.52) ONLY**

**WHEREAS**, by virtue of the invitation to apply for eligibility and to bid through Public Bidding in the website of the Commission and in the Philippine Government Electronic Procurement System (PhilGEPS), Region Security and Investigation Agency (RSIA) participated in the Public Bidding for the Security Services of PRC Tuguegarao Regional Office for the Year 2017 WITH THE APPROVED BUDGET FOR THE CONTRACT OF SIX HUNDRED EIGHTY TWO THOUSAND PESOS (PHP 682,000.00);

**WHEREAS**, on May 26, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidder may have and which was attended only by RSIA;

**WHEREAS**, on June 7, 2017, during the Opening of the bids held at the Office of the Regional Director, RSIA submitted their eligibility, technical and financial requirements;

**WHEREAS**, RSIA passed eligibility and technical evaluations and the RBAC opened its financial bid proposal with a bid price of **SIX HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED EIGHTY THREE PESOS AND FIFTY TWO CENTAVOS (Php681,983.52)** and was declared to be the Single Calculated Bidder;


**WHEREAS**, during the post-qualification on June 13, 2017 at No. 37 Diversion Road, Caritan Centro, Tuguegarao City, Cagayan, RSIA presented the original and certified true copies of their eligibility and technical documents.

**WHEREAS**, RSIA having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

**WHEREFORE**, the Regional Bids and Awards Committee RESOLVES, as it hereby RESOLVED, to recommend the award of contract for Security Services of PRC Tuguegarao Regional Office for the year 2017 to Region Security and Investigation Agency (RSIA), WITH A BID AMOUNT OF SIX HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED EIGHTY THREE PESOS AND FIFTY TWO CENTAVOS (Php681,983.52).
