### **TERM OF REFERENCE (TOR)**

# PROCUREMENT FOR THE MONTHLY GENERAL PEST CONTROL FOR THE PERIOD OF SEPTEMBER TO DECEMBER 2017

(Through Negotiated Procurement Pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184)

### I. OBJECTIVE

Monthly General Pest Control for rats, flying and crawling insects for the Main and Annex Building including PRC grounds for the period of September to December CY 2017.

#### II. SCOPE OF WORK

The General pest control should be conducted on weekends or holidays.

#### 1. General Pest Abatement:

- a. Spraying, misting, painting or brushing on infested surface areas with formulated insecticide; and
- b. Garden spraying and removal of beehive (if any).

### 2. Rat Abatement:

- a. Inspection of the premises for target locations (office, pantry, storage rooms, attics, garbage areas, etc.);
- b. Baits and rodenticides will be installed in the target locations; and
- c. Exterior inspection will also be conducted to check for possible entrances.

### 3. Flying Insects:

- a. Misting; and
- b. Fogging for external areas including drainages and canal.

### 4. Crawling Insects:

- a. Residual spraying on walls, floors, cracks and crevices, drainage, cabinets, baseboards and other breeding places;
- b. Use of pelleted roach bait and its powder form and / or application of spots of gel on surfaces, cracks and crevices and other hiding areas of ants and cockroaches; and
- c. Insecticides will be used in succession in order to prevent the pest from developing insecticidal resistance.
