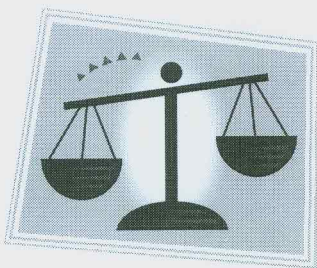

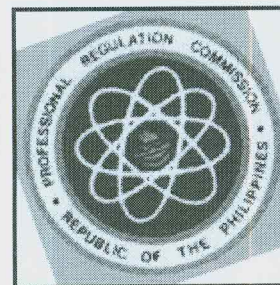

1.1	The Procuring Entity is the Professional Regulation Commission The name of the Contract is SUPPLY AND DELIVERY OF GOODS AND SERVICES FOR THE REHABILITATION OF THE PRC DATA CENTER with an approve budget for the contract (ABC) of Fifteen Million One Hundred Forty-Five Thousand Pesos (₱15,145,000.00). Which has one (1) aspect: The identification number of the Contract is: ITB No. 017-042
1.2	The lot(s) and reference is/are: One (1) project/Lot
2	The Funding Source is the Government of the Philippines (GOP) through the <i>General Appropriations Act of 2016 - 2017 and the Medium-term Information & Communications Technology Harmonization Initiative (MITHI) Fund</i> in the TOTAL amount of Fifteen Million One Hundred Forty-Five Thousand Pesos (₱15,145,000.00).
3.1	No further instructions.
5.1	Bidding is restricted to eligible bidders as provided by ITB clause 5.1
5.2	None of the circumstances mentioned in the ITB Clause exists in this Project. Foreign bidders, except those falling under ITB Clauses 5.2 (b), may not participate in this Project.
5.4	The Bidder must have completed a single largest completed contract that is similar to this project equivalent to at least fifty percent (50%) of the ABC, within the period specified in the Invitation to Bid and ITB Clause 12.1 a (ii). For this purpose, similar contracts shall refer to contracts for Supply & Delivery of Goods & Services for the Rehabilitation of Data Center.
5.5	The Bidder must submit a computation of its Net Financial Contracting Capacity (NFCC), which must be at least equal to the ABC to be bid, calculated as follows: $NFCC = [(Current\ assets\ minus\ current\ liabilities)\ (15)]\ minus\ the\ value\ of\ all\ outstanding\ or\ uncompleted\ portions\ of\ the\ projects\ under\ going\ contracts,\ including\ awarded\ contracts\ yet\ to\ be\ started\ coinciding\ with\ the\ contract\ for\ this\ Project.$ The values of the domestic bidder's current assets and current liabilities shall be based on the latest Audited Financial Statements submitted to the BIR. For purposes of computing the foreign bidders' NFCC, the value of the current assets and current liabilities shall be based on their audited financial statement prepared in accordance with international financial reporting standards. If the prospective bidder opts to submit a committed Line of Credit, it must be at least equal to ten percent (10%) of the ABC to be bid. If issued by a foreign universal or commercial bank, it shall be confirmed or authenticated by a local universal or commercial bank.

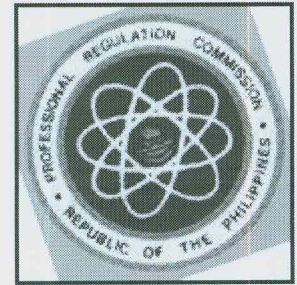
