RECOMMENDING TO THE PROFESSIONAL REGULATION
COMMISSION (PRC) CHAIRMAN THE AWARD OF THE CONTRACT FOR
SECURITY SERVICES OF PRC CAGAYAN DE ORO REGIONAL OFFICE FOR
THE YEAR 2016 TO AXZEEN SECURITY AGENCY, WITH THE BID
AMOUNT OF NINE HUNDRED SEVENTY THOUSAND ONE HUNDRED
FORTY PESOS AND SEVENTY-TWO CENTAVOS ONLY (₱ 970,140.72)

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding in the website of the Commission and in the Philippine Government Electronic Procurement System (PhilGEPS), Axzeen Security Agency and God's Well Investigation & Security Agency participated in the Public Bidding for the Security Services of PRC Cagayan de Oro Regional Office for the Year 2016 WITH THE APPROVED BUDGET FOR THE CONTRACT OF ONE MILLION ONE HUNDRED FIFTY EIGHT THOUSAND NINE HUNDRED THIRTY-FOUR PESOS ONLY (₱ 1,158,934.00);

WHEREAS, both bidders complied with the registration requirements of the Bids and Awards Committee.

WHEREAS, a pre-bid conference for the project was held on March 28, 2016 at the Office of the Regional Director, which was attended by Axzeen Security Agency and God's Well Investigation & Security Agency.

WHEREAS, during the opening of bid documents on April 15, 2016 held at the Office of the Regional Director, Axzeen Security Agency and God's Well Investigation & Security Agency, submitted its respective eligibilities, technical and financial requirements.

WHEREAS, during the evaluation of bids on April 15, 2016 held at the Office of the Regional Director, it was found out that God's Well Investigation & Security Agency failed to submit the latest income and business tax returns paid through the BIR Electronic Filing and Payment System (eFPS) within the last six months to the date of bid submission and was declared as "ineligible".

WHEREAS, Axzeen Security Agency was declared to be the Single Calculated Bidder and was subjected to post qualification process to determine its compliance with all the requirements and conditions for eligibility specified in the bidding documents.

WHEREAS, a site inspection was conducted on April 18, 2016 for post qualification; and
