RECOMMENDING TO THE PROFESSIONAL REGULATION COMMISSION (PRC)
CHAIRMAN THE AWARD OF THE CONTRACT FOR SECURITY SERVICES OF PRC
TUGUEGARAO REGIONAL OFFICE FOR THE YEAR 2016 TO REGION SECURITY
AND INVESTIGATION AGENCY (RSIA), WITH THE BID AMOUNT OF FIVE
HUNDRED SEVENTY THOUSAND SIX HUNDRED SIXTY-FOUR PESOS AND
SEVENTEEN CENTAVOS ONLY (\$\infty\$570,664.17)

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding in the website of the Commission and in the Philippine Government Electronic Procurement System (PhilGEPS), Kerygma Security Services, Inc. and Region Security and Investigation Agency participated in the Public Bidding for the Security Services of PRC Tuguegarao Regional Office for the Year 2016 WITH THE APPROVED BUDGET FOR THE CONTRACT OF SIX HUNDRED FIFTY-ONE THOUSAND TWO HUNDRED PESOS ONLY (P651,200.00);

WHEREAS, both bidders complied with the registration requirements of the Bids and Awards Committee.

WHEREAS, a pre-bid conference for the project was held on February 19, 2016 at the Office of the Regional Director, which was attended by Kerygma Security Services, Inc.

WHEREAS, during the opening of the bid documents on March 04, 2016 held at the Office of the Regional Director, Kerygma Security Services, Inc and Region Security and Investigation Agency, submitted its respective eligibility, technical and financial requirements.

WHEREAS, the abovementioned Security Agencies submitted their respective bid as follows:

Region Security and Investigation Agency – ₱570,664.17

2. Kerygma Security Services, Inc - ₱638,111.03

WHEREAS, the offer of Region Security and Investigation Agency is determined to provide the most advantageous terms for the Commission with the bid amount of FIVE HUNDRED SEVENTY THOUSAND SIX HUNDRED SIXTY-FOUR PESOS AND SEVENTEEN CENTAVOS ONLY (₱570,664.17)

WHEREAS, Region Security and Investigation Agency was declared to be the Lowest Calculated Bidder and was subjected to post qualification process to determine its compliance with all the requirements and conditions for eligibility specified in the bidding documents.





WHEREAS, a site inspection was conducted on March 10, 2016 to verify, validate and ascertain all statements made, and documents submitted by the bidder during the submission and opening of Bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that will be submitted by the bidder during the post-qualification.

WHEREAS, Region Security and Investigation Agency having passed the post qualification, was declared to be the Lowest Calculated and Responsive Bidder (LCRB).

WHEREFORE, the Regional Bids and Awards Committee (RBAC) RESOLVES, as it hereby RESOLVED, to recommend the award of the contract for Security Services of PRC Tuguegarao Regional Office for the year 2016 to Region Security and Investigation Agency, WITH THE BID AMOUNT OF FIVE HUNDRED SEVENTY THOUSAND SIX HUNDRED SIXTY-FOUR PESOS AND SEVENTEEN CENTAVOS ONLY (₱570,664.17).
